The agreement shall come into effect on June 18, 2018. Changes to this agreement shall be made with mutual consent between both parties. In cases of disagreement, parties wishing to depart from the agreement shall be reviewed whenever required.

#### MEMORANDUM OF UNDERSTANDING

Gokula Krishna College of Pharmacy shall hereafter be referred to individually as "party and collectively as "parties "as the case with the NV Kandriga Panchayat to promote and facilities recycling and also wants to engage with a satisfactory partner.

Whereas "Gokula Krishna College of Pharmacy wishes to ensure sustainability by enabling the responsible disposal of solid recyclables during the period 2022-2025.

Therefore, in consideration of the foregoing and the mutual promise between the parties under this agreement, the parties here agree as follows:

#### 1. Now this MOU witness is as follows:

This is an agreement for a synergic alliance between Gokula Krishna College of Pharmacy and NV Kandriga Panchayat for the cause of recycling solid waste and to protect the environment, conserve natural resources, inculcate the habit of source segregation among the citizens, recover and recycle the solid recyclables that are going to landfills, and provide a sustainable livelihood to the informal sector.

#### 2. Scope:

- The NV Kandriga Panchayat will provide a sustainability solution to Gokula Krishna
   College of Pharmacy for the responsible disposal of recyclables.
- A pickup request for disposable material will be generated at Gokula Krishna College
  of Pharmacy. Required services will be fulfilled by Recycling and its associated
  partners.

- 3. While this agreement is in force, **Gokula Krishna College of Pharmacy** shall ensure that all solid recyclables will be disposed of only through its associated partner.
- 4. Rates for recyclables will be displayed from time to time on recycle.
- Gokula Krishna College of Pharmacy will increase the value to be received against the disposable and recyclable.
- 6. The sustainability certificate for responsible disposal through the NV Kandriga Panchayat will be provided, and the same can be accessed.
- 7. Gokula Krishna College of Pharmacy is required to provide the necessary entry and existing permissions, including but not limited to gate-passes and other access formalities, to use its space for the loading of recyclables and manpower movement during the time of pickup.

#### 3. Indemnities

Gokula Krishna College of Pharmacy shall be solely responsible for the collection and storage of category-wise recyclables on their premises.

The NV Kandriga Panchayat will take the initiative to conduct an awareness drive with students at the college.

#### Term:

This agreement shall come into force from the date of signing and remain valid for a period of 36 months, including final payment and documentation, whichever is earlier, unless terminated earlier by the parties. The agreement may be extended for such further periods and quantities as may be agreed to by the parties.

Amendment: Any amendment to this agreement shall be valid and binding on the parties only if it is made in writing and signed by duly authorized representatives of each party.

Notices: All notices and other communications shall be sent to the address of each party set forth at the beginning of this agreement.
